Alpha Deltas are pleased to know that Cornell's new winter sports' area in the Carolines has been named "Tar Young Hill" in honor of *Prof. C. V. P. Young '99* of the department of Physical Education. "Tar" has been extremely interested in the new area and has even purchased some adjoining land.

The area has a 1000-foot ski tow which is completed except the placing of the rope. At this writing the rope has been held up because of priorities. A ski jump is just getting underway but should be ready soon after the scheduled opening of the area on January 5. Fireplaces have been built as warming spots, and will be augmented by a warming house. The center is on the main road which goes through Slaterville and is 13.2 miles east of the campus.

## Most Common Questions About Refinancing Plan Answered by Corporation

Here are some frequent questions and answers to the present refinancing plan:

Q. *How much is needed?*

A. \$80,000 which will pay the debt and interest over the five year period.

Q. *What is my share?*

A. There are about 400 alumni, which means \$200 from each man.

Q. *How does my participation in the Refinancing Fund help the house?*

A. Each dollar subscribed reduces the debt at the bank. Insurance carried by the house repays the individual, thus the mortgage is amortized.

Q. *What are the amounts of insurance?*

A. \$333, payable \$33 and \$5 a month for 60 months.

Q. *How much insurance does this give?*

A. \$500 insurance may be placed on anyone from 10 to 60, and anyone may be named beneficiary.

Q. *What will be the chapter's carrying charges?*

A. 4½% premium paid until death of insured.

Q. *How does the chapter benefit?*

A. Death of insured cancels the premium paid by the chapter, and also that part of mortgage subscribed by individual.

## We'll Have Three Terms Yearly

## Students May Be Trained On Campus While Studies, Program, Are Continued

What is the effect of the war on the Cornell Campus? At first glance, hardly any effect is apparent. However, changes are gradually coming about.

While there was considerable uneasiness and anxiety during the week following the outbreak of hostilities this condition was relieved somewhat when the University pounded the advice into us that we should stay on the books and carry on until called. There have been a few calls and enlistments on the campus, but nothing like the exodus of some 800 students during the first month of World War I.

At that time, the few fraternity men left maintained a chapter house with the empty rooms commandeered by the Army for the housing of soldiers sent here for training. And you can imagine that fraternity houses did not emerge unscathed.

The armed forces hope this time to train students on the campus while studies are continued. Drill may start at 6:00 a. m., and be interrupted for classes during the day. The plan is to disrupt college work only when necessary. We cannot predict the future of conditions at Cornell, but are given to understand any changes made will not be as drastic nor as disrupting as in 1917 when the University approached the status of a girls' seminary. We shall know more about local conditions and policies when we return from the holidays.
