## Retiring President Urges Continued Alumni Support

Brother Alpha Delt:

In February of 1981, I walked into the Alpha Delt house for the first time in 10 years. I found an establishment that had survived the bad times of the early and mid-'70s and seemed to me a still worthwhile institution. However, it was "failing to thrive."

Having some available time and energy, I decided to get involved. I started out by chairing the Maintenance Committee, added undergraduate operations, and in 1985 accepted the office of president of the alumni corporation. Along the way I also became treasurer of the then-dormant Adelpic Fund.

The six years have been at times trying and exasperating, but on the whole productive, inspiring, and rewarding. The physical plant has been put in good repair and is being maintained—no more crisis management! Several problems within the undergraduate organization have been resolved, and they have an increasing membership of outstanding Cornellians. The Adelpic Fund has been revived and revitalized, with a five-year fund drive under way that raised \$142,000 in the first year.

Most important, alumni participation and involvement has increased tremendously. Alumni dues in the current year are triple what they had been averaging, new blood has been brought into both organizations, and some board members have been

## ACEF Capital Fund Drive Enters Second Year

On a regional basis, our organization and support systems are yielding positive results. Active chapter participation on phoneathons has been extremely successful, and we will complete direct calling to every living Cornell Alpha Delt this year.

Our "lost brothers" list is a continuing and critical function. Tom Ellis '55 has accepted the job of keeping our books straight, while Christophe Bergen '76 was elected treasurer at the Alumni Weekend trustees meeting. Semiannual statements of financial condition will be mailed to all members of the ACEF commencing August 1987.

I would like to call to your attention the continued availability of tax saving when giving to the ACEF—an approved fund #16-6023220. Gifts of non-cash appreciated property remain deductible for their full market value, subject only to the alternative minimum tax in limited cases.

Particularly at today's elevated quotations for some stocks, such a gift—for instance, a share of Caterpillar at \$55.00, on which one has a cost of only \$8.00—makes a deduction of \$47.00 per share. At a tax bracket of 40 percent, this saves \$18.80 of income tax, making the gift cost only \$28.20, while the giver feels proud to give \$47.00 to a very worthy cause. Give 100 shares and save \$1,880.00.

Our treasurer will promptly handle and acknowledge each gift. Although securities are the easiest to handle, we can enter into transactions in real estate or other property in special cases. Think it over. If you do nothing else, you can save commissions.

### Treasurer's Report

Dues are up 300 percent. Life memberships are up 100 percent. Samuel Eells Clubs' founding life member is Robert Woods '44. Your brothers appreciate your loyalty and generosity, Bob! We thank you.

All bills are paid. More than 20 percent of all living alumni have contributed time and/or money this past year. Stage one of capital improvement—cosmetic upgrading and deferred maintenance—has been completed. Thank you for your support, advice, counsel, and participation.

Pride of membership, loyalty to traditional values, and planning for an assurance of perpetuity are topics to be consciously addressed during 1987-'88. We need more active alumni in the corporation. By active, I mean that we want to see you at Homecoming and initiation. We want your input at semiannual meetings. Issues of policy and organization should be resolved by a broad consensus rather than just by the board of directors.

Call me with your concerns, drop me a note if you're not pleased with what's happening, and bring your family to Homecoming on October 10. If you sent a check last year, don't forget us this year. Call your old roommate and tell him about Alpha Delta Phi 1987. Bring him back with you this fall. Believe me, it's good for the soul.

### Chapter Values Legacies

*Legacies are not guaranteed a bid.* If the legacy rushes faithfully (that is, attends rush events frequently and enthusiastically), he will receive very serious, and probably favorable, consideration. If he attends rush events sporadically on the assumption that he will receive a bid due to his legacy status, then he is probably mistaken.

We strongly request alumni brothers to encourage their sons and nephews to rush Alpha Delta. Please, continue to recommend candidates. We had a strong group of four legacy brothers in the house this year and look forward to a strong group in next year's rush.

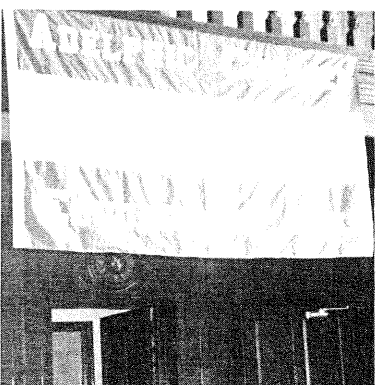
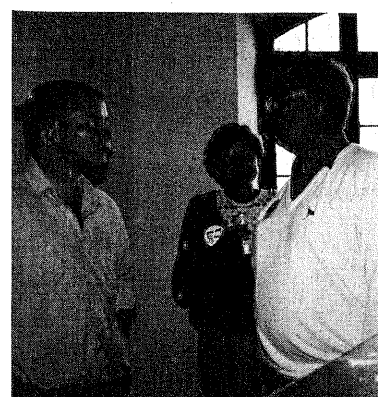
