## Cornell Star & Crescent Foundation Is Launched

It is with great pride and excitement that we announce the creation of the Cornell Star & Crescent Foundation, which has now received both state and federal approval of tax-exempt status. As many alumni brothers know, Alpha Delta Phi at Cornell University has been unable to provide a mechanism for channeling tax-advantaged donations into bricks and mortar improvements in the fraternity house. This inability to accept charitable gifts has not only hampered our fundraising for general operations and badly needed repairs, but it has put the fraternity at a competitive disadvantage in relation to other campus fraternities, especially university-owned fraternity houses that enjoy tax advantages under the Cornell University charitable umbrella.

Now, when you make a gift to Alpha Delta Phi at Cornell University via the Cornell Star & Crescent Foundation, your donation is deductible from your federal taxes.

The primary purpose for creating this new foundation is to take advantage of the improving posture of the Internal Revenue Service in approving financial support by a tax-exempt 501(c)(3) organization or foundation to its fraternity alumni association for maintenance, repair, and historic preservation of chapter houses. Alumni associations, like Alpha Delta Phi at Cornell, Inc., that qualify as corporations under 501(c)(7), but not public charities under 501(c)(3), are the entities that can most wisely manage the property and organizational needs, but not raise the funds because they cannot offer a tax deduction to the donors. Those days are over for Alpha Delta Phi.

Through the Cornell Star & Crescent Foundation, a federally designated public charity, donors can support the chapter house with donations to underwrite renovations and improvements related to education, e.g., libraries, study rooms, Internet and computer-assisted research equipment and infrastructure, as well as the related and pro-rated overhead and operating costs (taxes, insurance, and maintenance) of designated “educational” areas within the chapter house.

In addition, the Cornell Star & Crescent Foundation can provide certain kinds of financing for the same infrastructure

and capital improvements to the chapter house as the University devotes to its dormitories and living units, e.g., roof, exterior, fire and life safety, and capital improvements. The foundation can also fund scholarships and awards for undergraduate members, and other students and faculty members.

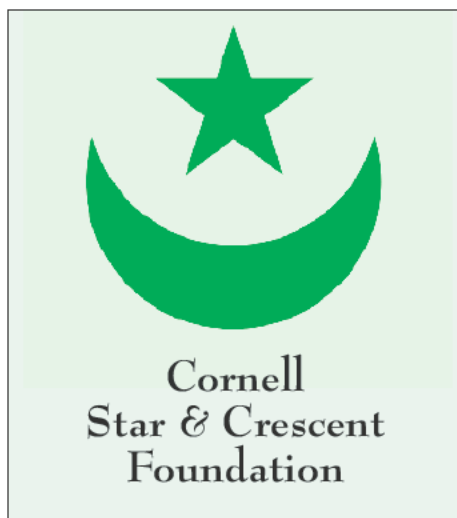
The broad goal of the new foundation is to improve the safety and health of the undergraduate residents residing at Alpha Delta Phi by addressing the infrastructure needs of the chapter house. While the university might pretend to be a conduit for that help, among the numerous drawbacks to using that vehicle is Cornell’s obligation to use and charge for its “in house” engineering and architectural services. More significant

is the fraternity’s concern that it will have to pay an extra 15 to 35 percent of construction costs—because, in the Ithaca area, Cornell is obligated by its trade union agreements to use only union contractors from a short list of qualifying contractors. However, there are many qualified contractors in the Finger Lakes region seeking construction and repair work that can significantly underbid the union shop contractors. The result is a large savings when the fraternity can control its own funds and select its own architects and contractors.

Many contributors, past and present, have hoped for a mechanism through which tax-deductible donations could directly help to preserve, protect, and defend Alpha Delta Phi—not only through polishing our reputation, but by

providing for the needs and requirements of maintaining and upgrading the safety and comfort of our facility.

Providing a first-class facility that remains competitive with other Cornell living options is an important key to ensuring the future of our self-owned chapter house on campus. We are in direct competition—not only with Cornell dormitories, but also with other fraternities, occupying Cornell-owned houses, which already have been benefiting from 501(c)(3) arrangements that allow those chapters to spend fully tax-deductible moneys on their facilities without calculating the educational space usage ratio, as we have had to do, up to this point.

# Building Our Tradition Never Rests... An Update On House Construction Projects

The summer months were very busy ones at the Phi for Dennis Flowers, our primary local contractor for house construction efforts. With financial support from generous alumni donations, numerous important improvement projects totaling \$100,000 were completed in time for the arrival of brothers back in the house on August 18, 2005.

Almost \$50,000 alone has been invested in new bathrooms for the Rotunda. New, easy-clean ceramic tile has been set along with a marble bench for bathing convenience. New commercial-grade sinks with hidden steel support girders have been installed. A new urinal was hung along with a new mirror over the sinks. Floors were cleaned with industrial-strength power-washing equipment and then re-grouted. New light fixtures featuring a star and crescent motif lend a distinctly fraternal touch to the lavatories. The doors on the commode stalls have been replaced with new locking doors that replicate the doors on the second floor hallway. New casement window frames (supporting sturdy fans that will alternately draw and vent air) will be installed by Homecoming 2005.

New front steps to the patio have been formed and set by a professional mason. The first two steps are made from molded concrete; the patio itself is made of stone. The former stairs, made of stone, could not handle the abuse from snowplows, moving vans, and dancing undergraduates. Speaking of stairs, the stairway leading from the card room to the dining room have been lifted, cleaned and polished, and reset in their original lead footings. The footings of the stairs had been badly damaged by water and teetered underfoot. The new stairs are firm, stable, and quiet.

In the aforementioned card room, new flooring has been installed to replace floorboards that had bent and warped after a pipe froze and burst in the Solarium last winter causing significant damage to the card room and dining room stairs. We still await a generous \$500 donation from a caring alumnus to

have the custom stained glass light fixture in the card room repaired and rewired. Will that kind and benevolent alumnus be you?

Dennis Flowers is presently working in the dining room repairing the three main tables which form a triangle, and 16 of the 45 custom chairs which have split seats and legs damaged from being dragged, not lifted, from one location to the next. Dennis is also plastering and painting the ceiling, replacing windows and screens, and cleaning the custom light fixtures that prominently feature stars and crescents.

Around the corner in the kitchen, you will find: significant removal of empty overhead lead pipes; degreased sinks, floors, and food preparation surfaces; new paint and plaster on three previously crumbling walls; and an aging stove. All the appliances in the kitchen need to be replaced in the next few years, but we really need to replace the stove, which has two unusable burners and heats unevenly inside. A restaurant-quality stove can be purchased used for approximately \$5,000.

Keeping up with repairs and improvements (large and small) at the Phi reminds one of the story of Sisyphus. We have 915 living alumni brothers. Annually, we receive contributions from 235 of our members, representing about 26 percent—or, approximately, one out of every four living brothers. # Alpha Delta Phi Cornell Tradition Fellowship Winners Are Announced

Initially established in 1998 through Cornell's Scholarship Challenge Campaign by John S. Dyson '65, and matched by generous Alpha Delt alumni donors, coveted Alpha Delta Phi Tradition Fellowships are awarded to undergraduates who demonstrate leadership potential and hold a leadership position in the chapter. The financial award is a scholarship grant—awarded through the Cornell Financial Aid Office—designed to relieve all, or portions, of the recipients' work-study requirements. By relieving these obligations, brothers are expected to provide service and leadership to their chapter.

The 2004-2005 award winners are Daniel Kaiser '07, of Danville, California, and John VanArsdale '05, of Bethany, Connecticut. Both brothers were awarded scholarships ranging from \$2,400 to \$3,500. Dan Kaiser, a former Alpha Delt stew-

ard, is a sophomore majoring in Hotel Administration. Jack VanArsdale, a former Alpha Delt treasurer, is a senior English major. The 2003-2004 winner was Josh Goldstein '05, a former house president.

In a letter to the board of Alpha Delta Phi at Cornell, Inc., Brother VanArsdale wrote, "Thank you so much for the scholarship, I am sure that my parents will be just as thrilled as I am. I really appreciate all the help that Mr. Dyson and the alumni board have given me in paying for my education, and I hope that in the future I will be able to do the same for my undergraduate brothers as an alumnus."

The Dean of Students, Kent L. Hubbell '67, has released the grade-ranking report for all Cornell fraternities for fall 2004. Alpha Delta Phi ranked 16th out of 40 chapters with an average grade-point average (GPA) of 3.261 among the 37 brothers. Zeta Beta Tau was ranked first (3.539 GPA) and Theta Delta Chi was ranked last (2.684 GPA). Once again, the Cornell Chapter beat the Cornell all-men's academic average, which was 3.235 GPA. The Cornell Chapter also beat all the other houses around McGraw Place including: Sigma Alpha Epsilon, Chi Psi, Sigma Phi Epsilon, and Phi Gamma Delta (FIJI). Congratulations to the undergraduates for their efforts to distinguish the Phi through their dedication to academic excellence.

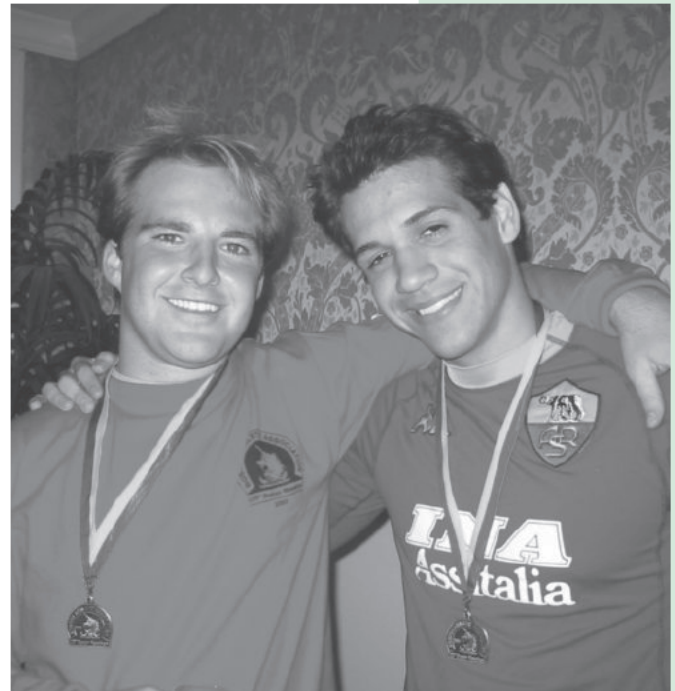

# Honoring The Memory Of Judge James E. Rice Jr. '30

**O**n a recent stop in Ithaca, Howie Schaffer '90 asked me if I'd like to go with him to pay respects on a visit to Adelaide, Judge Rice's wife. The last time I had seen her was at the Johnson Museum reception to honor Brother Rice, more than a decade ago, and I had expressed the hope then that alumni and actives might keep in touch with her, especially after her years of support for Alpha Delt. Howie and I drove out to the Rice farm in Trumansburg, familiar to many of you; and Adelaide was glad to see us. Before long, we were looking out on the fields where had stood the Christmas trees which Jim had cut to reach the full height of the Great Hall ceiling. Howie and I were surrounded by the awards Jim had received for his considerable community service in Tompkins County, as well as his years as a brother. Adelaide literally took many of the fraternity-related plaques off the wall and handed them to us to put in "safe keeping." They are now part of the Alpha Delta Phi Collection at Kroch Library. We thanked her profusely for the donation.

Over a leisurely pot of tea and two plates of cookies, we

recalled the years of brotherly trips to the farm in the house fire engine, "777," and Jim's continuing presence as corresponding secretary, advisor, and friend. She told us a story of a house party in the 1930s where she and Jim danced into the wee hours of the morning and then fell asleep on one of the couches in the Solarium. A small scandal ensued when chaperones discovered them asleep the next morning. She recounted many special memories of chicken roasts at the farm and elegant evenings at the Phi.

Of course, the story of Jim's trip down the lawn on the house piano as the old prairie-style Alpha Delt lodge burned in February 1929 was retold. Adelaide is healthy and living independently, with some help from family and friends. She spends parts of each winter traveling to St. Lucia and Florida. She is an accomplished painter and showed us many of her vivid impressionistic watercolors.

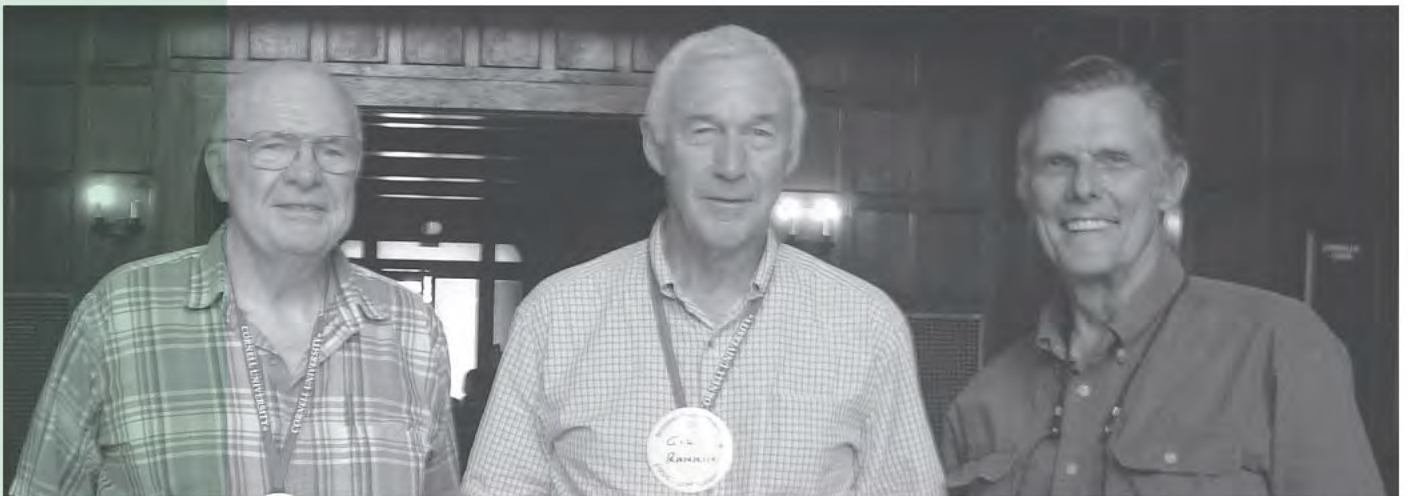

Fraternities at the Massachusetts Institute of Technology (MIT) have obtained an Internal Revenue Service ruling that broadly signals that all normal operating expenses for a fraternity facility may be paid for by tax-deductible educational dollars that are similar to those spent by a college or university for a dormitory facility that is college or state owned. To that end, the foundation at MIT that supports the fraternities and sororities with loans using tax-deductible dollars is now making grants each semester for operating expenses to fraternities and sororities that meet certain standards. Thus, to keep up with the changing trends at Cornell and across the country, the Cornell Star & Crescent Foundation has been formed, in part, to provide the necessary legal mechanism by which our members can best support the continuing success of Alpha Delta Phi.

Guided by reason and prudence, the new Cornell Star & Crescent Foundation will lead the charge in making sure that resources are available to ensure that our beloved fraternity house is ready each August to invite a new class of Alpha Delt brothers into positive and beneficial traditions and experiences that will transform their lives and instill in them an obligation to give something back to the Phi to repay their debt to their forebears.

In future issues of the *The Cornell Alpha Delt*, I will update alumni brothers on the progress of the foundation.
