A Proud President Reports: Alpha Delt Buzzing With Activity

The Alpha Delta Phi house has been buzzing with activity this fall semester as the Newly Initiated Brothers settle into their new home. Though the Phi has fewer members living in this year, due primarily to the disproportionate number of brothers last year who were seniors, the house maintains its fullness as the majority of brothers still congregate nightly for house dinners and social events. As a result of the shift in residency, those brothers living in have been afforded great opportunities to improve the newly available extra rooms, many of which now serve as comfortable common lounges.

By way of painting, installing new hardwood floors, re-carpeting, and renovating, most of the undergraduates living in the Phi have invested a great deal in the rooms this year, adding considerable value to the accommodations and making the house a more comfortable place to call home.

Improvements to the physical plant are not limited to bedrooms, however. On the main level, the pool table in the Solarium has received a handsome, custom wood cover. The dark-stained wood is accented by gold-leaf lettering, a project undertaken primarily by brothers James Teague '09 and Pierre Estey '11. The cover now bears the Star and Crescent, the Greek letters, Alpha Delta Phi, and the years of the fraternity's founding (1832) as well as the Cornell Chapter's founding (1869). Resting below our beloved Victory Club lamp, the cover not only protects the pool table when not in use, but acts as a centerpiece of the Solarium.

Down in the Music room (the large room connected to the Pit), brothers Jerome Soustra '11 and Jesse Suchoff '11 have cleared out what was a storage room and converted it into a double bedroom. The two put their creativity to work and painted a mural spanning three of the four walls, featuring skylines, portraits, poetry, famous quotes, and a sketch of the Goat House. The two architecture students used some of the older furniture from the main floor that was replaced last year to form a cozy lounge by the fireplace, successfully creating yet another great social gathering spot in the house.

Additionally, I am proud to report that in our most recent chapter meeting, the undergraduates voted to bring back the tradition of fall protocols. Sometime around the early-to-mid 2000s the ritual of holding formal protocol dinners twice a week fell out of practice. The brotherhood is excited to rekindle this tradition central to our literary roots and, we hope, bring the undergraduates even closer together.

Alpha Delta Phi's social schedule is no exception to the positive set of improvements this semester. After starting the semester off with

a few large open parties, Alpha Delta Phi moved to hosting smaller "Tower Hour" parties. Hosted on the tower, the brothers held smaller-scale parties that allowed brothers better opportunities to meet potential rushees and accent one of the best features of the house—the tower, at least while the weather allowed it.

Along the lines of rush, the brotherhood is looking forward to a strong rush year, hoping to compensate for the smaller size of

the fraternity this year by setting an ambitious target of 24 pledges.

Under the leadership of Rush Chairmen Alex Lebowitz '09 and Jacob Goldstein '10, as well as Assistant Rush Chairman Roger Tufts '11, the brothers have begun planning weekly invitation-only coat and tie cocktail receptions, an event successfully utilized last year to invite rushees to the house to meet the undergraduate brothers in style.

All in all, the brotherhood is looking forward to a great semester. With athletes on the golf, sprint

football, and crew teams, brothers from every undergraduate college, 10 brothers who achieved Dean's List, two pilots, and a fine group of musicians, the Alpha Delta Phi house is stronger than ever.

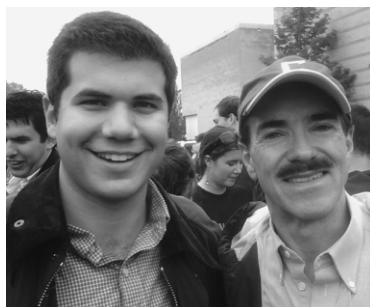

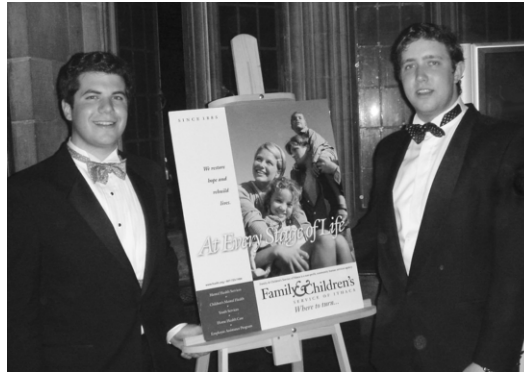
ΑΔΦ Philanthropy Recognized by Family & Children's Service

Cornell Students are Philanthropic

Family & Children's Service of Ithaca has long enjoyed a great working relationship with Cornell, providing the staffing for the university's Employee Assistance Program and a preferred referral partner with Gannett's Counseling and Psychological Services (CAPS) program. We have also been the grateful recipient of generous philanthropy from Cornell and enjoyed many Cornellians as board members and volunteers with our agency.

Cornell students have also volunteered and interned at our agency for many years. As an agency dedicated to the welfare and well-being of young people, we have always been keen to engage with Cornell students. This spring, various Cornell student groups donated more than \$11,000 to benefit various programs and special initiatives at Family & Children's Service.

The Alpha Delta Phi Fraternity's Victory Club Casino Night event raised \$6,500 for our children's mental health clinic capital expansion.

The most compelling part of all these wonderful donations is they were done on our behalf without us asking the students to do so... they chose us for their good deeds and donations! We are sincerely grateful of Cornell's active and engaged philanthropy and community service to Family & Children's Service of Ithaca and our entire community.

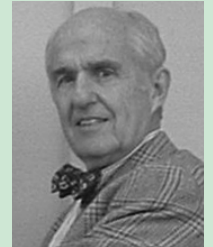
Victory Club Commended by Fraternity and Sorority Advisory Council

These Greeks Still Have a Word for It – Χαίρε

“The Greece I love,” says Lawrence Durrell; “poverty that brings joy without humiliation, the chastity and fine manners of the islanders, the schisms and treacheries of the townsmen . . . the taverns with their laurel wreaths, the lambs turning on the spit at Easter, the bearded heroes, the shattered marble statues.”

And he gives the meaning too, in his 1945 book, *Prospero's Cell and Reflections on a Marine Venus*: “When you see the gravestones from the little necropolis of Cameirus . . . it is the so-often repeated single word -- the anonymous Xaïpe -- which attracts you . . . It is not the names of the rich or the worthy . . . but this single word, ‘Be Happy,’ serving both as a farewell and admonition, that goes to your heart with the whole impact of the Greek style of mind, the Greek orientation to life and death: so that you are shamed into . . . realizing how little you have fulfilled . . . a thought so simple yet so pregnant, and how even your native vocabulary lacks a word whose brevity and grace could paint upon the darkness of death the fading colors of such gaiety, love and truth as Xaïpe does upon these modest gravestones.”

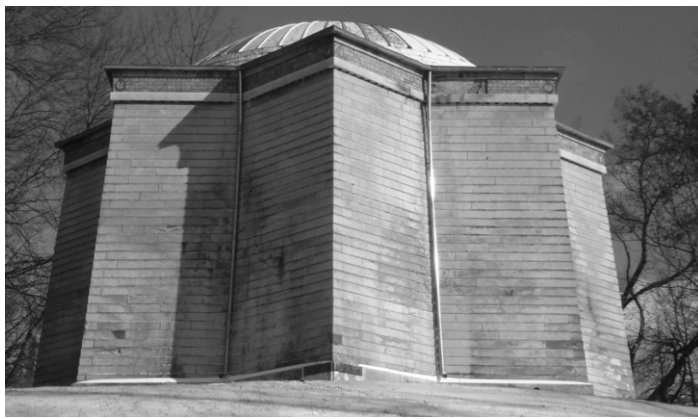

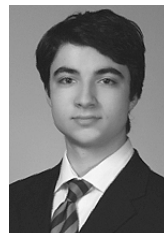
Joseph Salameh '10 Wins AΔΦ International Seward Scholarship

Fall 2008 Undergraduate President Joseph Salameh '10 was recently named a 2008 winner of the prestigious Seward Scholarship.

The scholarships are named for Clarence Armstrong Seward, Geneva 1848. Brother Seward enjoyed an esteemed career as an attorney in New York City representing railroad and industrial interests. In 1897, during his tenure as president of Alpha Delta Phi International, the Seward Scholarship Fund was established to honor the contributions made by Brother Seward during his many years of service to his fraternity. To this day, the fund grants scholarships to undergraduates on the basis of financial need, achievement in Alpha Delta Phi, and activities on campus. The fund is administered by a committee appointed by the International Board of Governors. (Brother Seward is often inaccurately interchanged with his uncle, William H. Seward, who is best known for his role in the United States' purchase of the territory of Alaska, "Seward's Folly," when he was U.S. Secretary of State during the administration of President Abraham Lincoln.)

Joseph writes, "I want to thank Howie Schaffer '90 for his strong endorsement of me for the Seward Scholarship. Andrew Lyon '10 notified me when my win was announced at the 2008 summer ADPhi Convention in Berkeley. 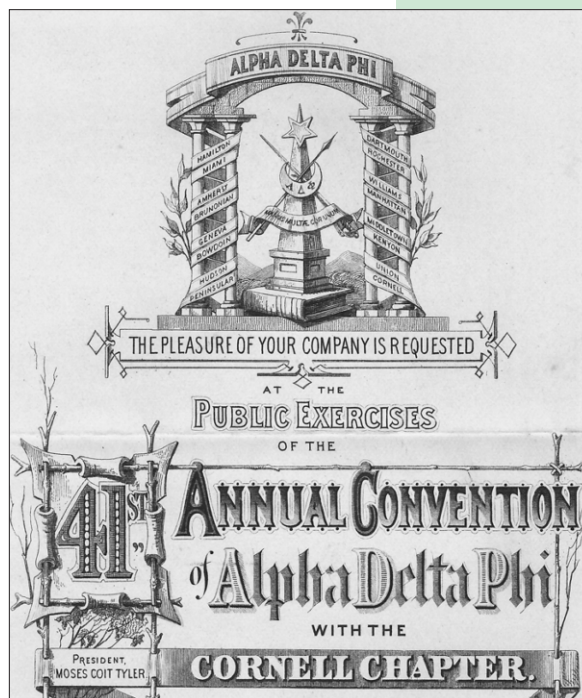

Tributes To Our Esteemed Alumni

John A. Brooke '57



John A. Brooke '57

John A. Brooke '57 was an Alpha Delt legend in his own lifetime. In the early 1970s, he accepted the responsibility of running the alumni corporation, solving the crisis of several years of unpaid taxes, renovating a deteriorating chapter house which was less than half occupied, and re-engaging alumni interest in the survival of Alpha Delta Phi at Cornell University. John raised the money to pay the taxes and to install a sprinkler system. He worked with the actives to rebuild their membership. The strength of the Phi today is a testament to John's leadership and dedication at a time of crisis. In 1991, the John A. Brooke Fund was established to honor his stewardship and to provide funds for continued upkeep and maintenance of the physical plant of Alpha Delta Phi. Brooke was a hotelier by profession, and served as president of the alumni corporation from 1970-1972. Thanks to John, 777 Stewart Avenue continues to be a place for nurturing the values and excellence that embody the spirit and mission of Alpha Delta Phi.

Theodore F. Olt '57 recalls:

"John wasn't just a friend; the Olt family and the Brooke family grew up together and enjoyed many happy days and hours together, whether skiing, swimming, or playing football in the front hall of the home in Lake Forest. Yes, we broke a fixture every now and again! But that was John—life was to be lived to its fullest. We met very early in our years at Cornell—at the Alpha Delt house. John, his brother David Brooke '50, and I were legacies. We went through pledge training and initiation together and, as we matured, assumed positions of leadership in the house. Predictably, John was social chairman and I was treasurer. It is strange that we became close friends, because we clashed often. John taught me the concept of capital spending. He pointed out that the money he had overspent on a new bar should be capitalized because that bar would last for 50 years. It did last more than 25. So, I found a way to scrounge the cash. John was an entrepreneur even then, as he possessed the house concessions for laundry and beer. John sold on credit and I took care of the receivables. I could write for hours about the great parties and times we enjoyed at Cornell.

It is most appropriate here to pay tribute to his wife, Gigi. These were busy years for John as his involvement with Holiday Inn went far beyond the management of his own facilities, and his commitment to home and family was intense. It took a very strong woman to hold it together and maintain some semblance of order. During these years John gave much of himself to the Hotel School at Cornell and to his fraternity. He assumed the presidency of the alumni corporation and literally saved the fraternity from financial ruin and extinction. He was honored with the establishment of the John A. Brooke Fund for the upkeep and maintenance of the physical plant. He was elected to the ADPhi Hall of Fame—one of only 13 such elections over a 150-year period. His biography in the chapter archives lists him as "a legend in his own time" and, indeed, those of us who knew him well know that to be true. It is those family and institutional values that keep coming back into my memory. I shall remember John as the guy that got things done—and done right. Kind, generous, innovative to be sure, and with Gigi, a creator of very strong family values."

The career of **Douglas Cain Yearley '57** took him from president of the Phi to chairman and chief executive of the copper-producer Phelps Dodge. Last October, Douglas died of multiple myeloma, a disease Doug had been fighting for the last few years, which didn't stop him from being active in his family and professional life until the very end.

On the Hill, Doug studied metallurgical engineering, a rigorous program that graduated only seven students out of 22. In such a competitive academic environment, Doug was a conscientious and hard working student, though, like all Alpha Deltas, he balanced work and play. Indeed, he met his wife, Anne, during a fraternity mixer with some ladies from Wells College.

Doug joined Phelps Dodge in 1960 and spent four decades there. He engineered the \$3.34 billion acquisition of the Cyprus Amax Minerals Company—at the time, the company's largest purchase in its 165-year history. He was elected executive VP and a director in 1987, chairman and CEO in 1989, and president in 1991, retiring in May 2000. Doug always remained true to his values—regardless of the demands of his many professional endeavors. He was, as every Alpha Delt strives to be, a true gentleman.

Doug is survived by his wife, Anne; a daughter, Sandy; three sons, Doug, Peter, and Andrew; a brother; and 15 grandchildren.
